VILLAGE OF SOUTHAMPTON - BEACH PARKING PERMIT INFORMATION

You may now receive your 2020 Village Beach Parking Permits by mail or In Person at Village Hall.

Effective June 10, 2020 Village Hall will be open to the Public: Monday – Friday from 10AM – 2PM.

There is also a Drop Box in the front of Village Hall and permit requests as outlined below may be placed in that box. Orders will be processed upon receipt and will be mailed back to you PROVIDING you have included a **STAMPED-SELF-ADDRESSED ENVELOPE**

If you want a [Southampton Town](#) beach pass, you must contact the [Town](#) at 631-728-8585 or view the [application online \(PDF\)](#). We encourage all residents and non-residents to take advantage of this service.

Please note, due the Covid-19 pandemic, the Board of Trustees has set new protocols to protect the health and safety of the community and the Village employees and have amended the regulations for the 2020 Beach Parking Permit.

TO PROCESS YOUR PERMIT BY MAIL WE WILL REQUIRE A COMPLETED APPLICATION WITH THE FOLLOWING:

FOR SOUTHAMPTON VILLAGE RESIDENTS

- A copy of a valid car registration for each car for which you want to receive a permit.
- A copy of your current tax bill.
- A telephone number in case we need to reach you for more information.
- A self-addressed stamped envelope where you want your permit sent. If there is not a S.A.S.E. we will not send your permit out. **It is suggested that you include a form of tracking on the S.A.S.E.**
- Village Property Owners are eligible for **3 permits** at no additional fee.
- As of June 12th residents may purchase One (1) Summer Visitor Permit at \$450 for a family member.

FOR YEAR ROUND RENTERS IN THE VILLAGE

- A copy of a valid registration for each car for which you wish to receive a permit.
- An original utility bill showing your name and service to Village address from the prior April/May, winter and current.
- A telephone number in case we need to reach you for more information.
- A self-addressed, stamped envelope (S.A.S.E.) where you want your permit sent. If there is not a S.A.S.E. we will not send your permit out. **It is suggested that you include a form of tracking on the S.A.S.E.**
- Year-round renters are eligible for 3 Resident Permits

FOR "LOCAL" NON-RESIDENTS: (RESIDING WITHIN SOUTHAMPTON FIRE OR SCHOOL DISTRICT)

- A check or money order made out to the Village of Southampton in the amount of \$250 per car. (Senior citizens / Veterans \$175 - one vehicle per household)
- A copy of a valid registration for the car for which you wish to receive a permit.
- A copy of your Southampton Town tax bill.
- Seniors must provide an ID card with DOB (must be 65 by 9/7/20); Veterans must provide a copy of their Military ID or a DD214.
- A telephone number in case we need to reach you for more information
- A self-addressed stamped envelope where you want your permit sent. If there is not a S.A.S.E. we will not send your permit out. **It is suggested that you include a form of tracking on the S.A.S.E.**
- **** As of May 22nd, "Local" Non-Village residents, may only purchase 1 permit per residence.***

FOR "SUMMER VISITORS" ONLY

- ****As of May 22nd, Summer Visitor passes will Only be available for vehicles registered to individuals renting in the Village of Southampton for 30 days or longer – ONE permit per household.***
- A check or money order made out to the Village of Southampton in the amount of \$450 per car - there are no senior discounts.
- A copy of your lease identifying property in the Village and terms of lease as 30 days or longer.
- A copy of a valid car registration for the vehicle you want a Permit for – 1 Permit per household.
- A telephone number in case we need to reach you for more information.
- A self-addressed stamped envelope where you want your permit sent. If there is not a S.A.S.E. we will not send your permit out. **It is suggested that you include a form of tracking on the S.A.S.E.**
- *Village Property Owners may purchase One (1) Summer Visitor Permit for a family member.*
- **** Hotel, Motels and BNB's must purchase a minimum of 10 permits.***

VILLAGE 4X4 PERMITS

To obtain a Southampton Village 4x4 permit, please mail the following:

A copy of your receipt for your 2020 Southampton Town 4x4 Permit

A copy of your 2020 4x4 Permit issued by Southampton Town OR a copy of the registration for the vehicle you are requesting a permit for.

MISCELLANEOUS:

- ***Little Plains Beach will now be a RESIDENT ONLY Beach and Resident Beach Stickers must be on vehicles.***
- **All regulations for Village Employees and Volunteer Fire and Ambulance members remain unchanged.*
- *Tour busses may not drop groups off at any Village beaches.*
- *Village Hall is NOT handling any in-person transactions.*
- *The Village will be installing a drop box in front of Village Hall beginning Monday, May 18th.*
- *There will be NO permit transactions at Coopers Beach.*
- *Please adhere to signage at the Beaches and follow these regulations:
Maintain Social Distancing of at least 6 feet
Wear Masks to and from the car to the Beach and when social distancing isn't possible.
Please dispose of garbage in the trash receptacles or take with you when you leave the beach.
DO NOT leave garbage behind --dispose of gloves or masks in the receptacle or take with you.*

Please be sure to enclose the items listed above for prompt and efficient service.
