Highsmith feels that it blends in and is set back further, he has not issue with the gates. R. Coburn asked if there is a light carved in a niche in the pier. D. Thorp stated that there is a down light recess carved in. It will be LED – 1 or 2 watts. Since it is down facing and recessed into the pier the Board had no issue.

#### **PUBLIC HEARINGS – HISTORIC**

On the application of **CORCORAN**, 24 Main Street, Chandler Pierce was present for the applicant. The changes to the façade are painting with a Benjamin Moore white, proposing to take down two lights and put 4 lights up, there is a cut sheet of the proposed light. The proposed lantern is both up and down lit. S. Stevenson feels it looks showy to have the 4 lights. C. Pierce states they will be low wattage. J. Brodlieb doesn't like that it is bringing attention to the architecture, it's not the purpose of lighting. S. Stevenson has a problem with the 4 lights, she feels 2 is more appropriate. The number and brightness is the issue. C. Highsmith asked if the goal is to illuminate the building more. C. Pierce states it is to give the building more presence. There will be lit real estate boxes on the front as well, for that reason R. Coburn doesn't see a need to celebrate the architecture with lighting. C. Highsmith noted that lighting is for the purpose of illuminating signs, not accentuating architecture. J. Brodlieb feels it is unnecessary. R. Coburn feels it sets a precedent as to lighting in the future. There needs a light at the entrance or exit, but not lighting for architecture. J. Brodlieb stated above and beyond anything that is present there now, he's not in favor. C. Highsmith stated possibly more light is necessary in the Village, however, he feels what is presented is not appropriate. He would be more in favor of sticking with what is there currently.

C. Pierce submitted three cut sheets of alternative options for lanterns. His preference is a simple rectangle lantern. He would use two in the current locations with low lumen lights.

They also have a proposed new front door with Corcoran in writing, R. Coburn likes the original Palladian window. C. Pierce states it is not original to the building. Chair Stevenson asked if anyone on the Board has an issue with it, no one on the Board had an issue. The planters are not a problem for the Board and the façade is attractive to them. R. Coburn wanted clarification on an element above the door on the left in a photo. It appears to be an alarm box that will be removed.
